61 **Parish Councillors Reports:**

Cllr John Yelland – Wiltshire and Swindon Police and Crime Commissioner, Angus Macpherson is looking for feedback from Local residents on policing, and whether they would be prepared to pay an extra two pounds a month, on average, for more officers in the county. The policing precept is collected with our Council Tax and goes directly to the Police and Crime Commissioner where 98% is allocated to the Chief Constable and the remaining 2% to the PCC's office for commissioned services which includes supporting victims of crime and restorative justice. This would raise the average Wiltshire household contribution to £17.19 per month. It was agreed that the Parish Council had no objections to this rise.

The latest available crime figures available are for November 2018 which show there were seven incidents; 2 anti-social offence, 1 offence of theft, 2 violent crimes and 2 vehicle crimes.

Cllr Yelland encouraged everyone to join the Community Messaging Service to receive alerts regarding crime, scams and neighbourhood watch etc.

There appears to be a few irresponsible dog owners who are still failing to pick up their dog poo.
